I would be grateful if you could let me know the investment funds, unit price used, the number of units bought as well as the unit price and number of units Deirdre Abram could have bought if you had received the £12,527.44 from us on 30th August 2023.

Could you also let me know current bid and offer prices for the units.

If this isn't a unitised scheme, please could you let me know details of the investment and how much (if any) loss Deirdre Abram has incurred by way of pricing changes or investment returns based on if you had received £12,527.44 from us on 30th August 2023.

I've included a Loss Assessment Information Form for you to complete to assist us with assessing the loss.
