- Alexander Chapel Associates Limited SSAS Pension Scheme (in this Deed called the 'Scheme') is a pension scheme which was established by a Declaration of Trust dated 1st July 1997 and is currently governed by Rules adopted by a Deed of Amendment Adopting Replacement Provisions dated 6th September 2021 and all subsequent amending deeds and documentation (in this Deed called the 'Existing Provisions').
- 2. Under Rule 2.1.2 The Principal Employer has the power to remove a Trustee of the Scheme.
- 3. As a consequence of the retirement of the Outgoing Trustee of the Scheme, the Trusts shall remain vested in the Continuing Trustees.
- 4. Effective In this Deed (including the recitals) "Effective Date" means the date of transfer of the cash equivalent value of pension benefits held by the Outgoing Trustee in their capacity as a Scheme member.

Operative provisions

- a) The Principal Employer under the power vested in them by Rule 2.1.2 removes the Outgoing Trustee as a Trustee of the Scheme.
- b) The Outgoing Trustee is discharged from the office of Trustee with effect from the Effective Date and the Trust shall be vested in the Continuing Trustees.
