Hi Mark

I write in connection with the above pension scheme. You may recall that our firm was appointed to provide consultancy to the Trustees of the pension scheme in order to attempt to resolve its various issues.

We hold some funds on account for the trustees, having been sent them in respect of anticipated fees. However, our work with the scheme appears to have concluded, and it is no longer appropriate for us to retain the funds.

I understand from the files we hold that Meade King LLP holds (or held) the cash funds for the pension scheme in escrow. The solution would appear to be for us to return the monies held on account to the escrow account, and I have written to Meade King to suggest this. The amount in question is around £2,800.

If the Trustees have alternative proposals, which are agreed by all, then please let me know what they are. For obvious reasons I would need to see documents confirming each trustee's agreement. I have sent a similar email to those of the other trustees for whom we have details to let them know this is what we have in mind.

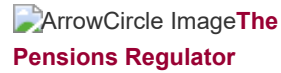
