ACTION YOU NEED TO TAKE FOLLOWING PENSIONS LEGISLATION CHANGES INTRODUCED FROM 6 APRIL 2006

Thank you for signing and returning the Deed of Amendment and Administration Services Agreement.

Please find enclosed the executed deed together with a copy of the service agreement. These are important legal documents and we suggest you keep them in a safe place for future reference.

As we are no longer a trustee of your pension scheme, you need to take steps to:

- 1. Remove us as a named owner of the investments held in the scheme, and
- 2. Register as Scheme Administrator for your scheme with HM Revenue and Customs.

Further details of these steps are described below.

1. Removal as named owner of investments

You need to amend the ownership of the investments so that they are registered into the names of the continuing trustees. This will include removing us as a joint signatory to the scheme's bank account.

The enclosed schedule provides details of how to re-register some of the most common types of scheme investments.

The trust deed provides that the principal employer reimburses the costs you incur whilst administering the scheme. You are entitled to be reimbursed direct from the scheme's investments in the event that the principal employer does not pay.

2. Scheme Registration

Your pension scheme is a tax approved pension arrangement. Following the regulatory changes introduced from 6 April 2006, generally referred to as A-Day, the scheme will automatically become a Registered Pension Scheme. However, HM Revenue and Customs (HMRC) need to know who is responsible for the scheme's administration. Therefore, you will need to register the details of the continuing trustees as the scheme's Administrator on the HMRC website. Access to the relevant forms can be gained by going to the following address:

From A-Day, you will be responsible for completing self-assessment tax returns and reporting certain transactions or events on-line. You might wish to appoint a practitioner or tax adviser to do this for you. HMRC will impose significant penalties on you if you do not comply. Details regarding reportable events and other requirements can be found on page RPSM12301000 of the HMRC website at the following address:

Deadline for re-registering

The re-registration of the scheme's assets should take place as soon as possible so that we no longer need to counter-sign any cheques from the pension scheme bank account or any documentation in respect of the existing investments. If re-registration is not completed within 6 months of the deed being executed we will charge for signing such documentation in the future.
