Good Afternoon Georgina,

Thank you for the enquiry.

We have looked through the records and can confirm that four debt repayments credited the pension scheme.

They were as follows:

- Repayment 1 - 02/12/2016 - £11,200 Capital plus £3,817.97 interest = Total £15,017.97
- Repayment 2 - 01/12/2017 - £11,200 Capital plus £3,284.98 interest = Total £14,484.98
- Repayment 3 - 10/10/2018 - £11,200 Capital plus £2,667.75 interest = Total £13,867.75
- Repayment 4 - 12/03/2020 - £11,200 Capital plus £2,940.00 interest = Total £14,140.00

Unfortunately we only have statements on file showing repayments 2, 3 and 4; we do not have a copy of the statement showing the first repayment. Please find attached the statements as requested.
