Deed of Association of a Participating Employer

## **Parties**

- 1 **Malcolm Bowers and Lynne Bowers** both of High Barn Cottage, 120 Paddock Road, Kirkburton, Huddersfield, HD8 0TT and **Benjamin James Bowers and Lucy Bowers** both of Toll House, 87 Denby Lane, Upper Denby, Huddersfield, HD8 8TZ (in this deed called the "**General Trustees**"); and
- 2 **Blow Investments Limited** (Company No 12677392) whose registered office is situated at Old Linen Court, 83-85 Shambles Street, Barnsley, South Yorkshire, England, S70 2SB (in this deed called the "**New Associated Employer**").

## **Recitals**

- (A) **Bowers SSAS** (in this Deed called the "**Scheme**") is a registered pension scheme which was established and is currently governed by a Trust Deed and Rules dated 1<sup>st</sup> October 2016 (as amended by a Deed of Amendment and Cessation dated 20<sup>th</sup> March 2019) and all subsequent amending documentation (in this deed called the "**Existing Provisions**").
- (B) The General Trustees are the current member trustees of the Scheme.
- (C) The General Trustees wish to appoint the New Associated Employer as a participating sponsoring employer to the Scheme.


## **Operative Provisions**

3. The New Associated Employer in question covenants to comply with those provisions of the Rules which apply to a Participating Employer with the consent of the General Trustees.
4. The provisions of this deed shall have effect on and from its date.






