## **Deed of Removal of Practitioner**

## **Parties**

## Introduction

- 1. The Trustees are the present trustees of **Burn Investment Scheme** (the "**Scheme**"), which is a retirement benefits scheme governed by a Replacement Trust Deed and Rules dated 5<sup>th</sup> July 2007 and all subsequent amendments and documentation (the "**Existing Provisions**").
- 2. Clause 5.1 of the Existing Provisions vests in the Trustees all the powers, rights, privileges and discretions they require for the proper implementation of the Scheme, including the performance of all duties imposed on them by law.
- 3. Clause 5.4 vests in the Trustees the power to appoint and remove advisors and officers as they consider desirable.
- 4. The Trustees are desirous to remove the Practitioner from the Office of Practitioner.

## **Operative Provisions**

The Trustees (in acting in their capacities), remove the Practitioner as their agent and Practitioner in connection with, but not limited to any matters within the responsibility of HMRC and any other thing whatsoever in connection with or incidental to the discharge of all duties relating to the Scheme which are imposed on the scheme administrator and/or the maintenance of the registered status of the Scheme under Part 4 of the Finance Act 2004.

The provisions of this Deed have effect on and from its date.
