Good Afternoon Georgina,

Thank you for the email.

Thanks for sending the deed across.

We have associated Tony's ID to the scheme, once accepted we will remove TWS Pensions.

Please find attached a copy of the HMRC registration letter, we do not have a copy of the latest ICO certificate on file.

We have added your email to the scheme on The Pensions Regulator exchange. The return has already been submitted.

In order to close the existing bank account and transfer funds to the new scheme bank account we will require the attached RBS account closure authority to be signed by all members and returned to us. We will then counter-sign and send to RBS who will close the account.

Please find attached a transaction statement from 1st April 2019 to date.

The current split of the fund is as follows:

Both Emma and Colin are 100% uncrystallised.

Tony took a PCLS payment in 2018 and the split of his share of the fund is currently:
