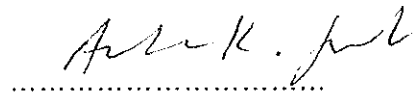
The Articles of Association dated 12/06/2000 are in force at the date of this Resolution.

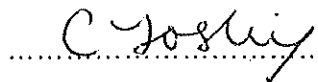
The directors have resolved to create a class preference B shares the rights attaching to those shares shall be set out in the attached schedule. Further that:

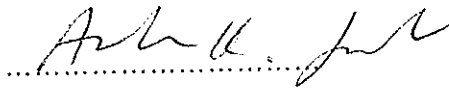

The Articles of Association dated 12/06/2000 are in force at the date of this Resolution.

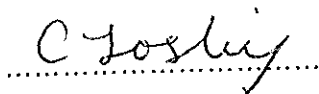
By way of a Shareholders' ordinary resolution, the company is empowered to issue shares with such rights or restrictions as may be determined by ordinary resolution.

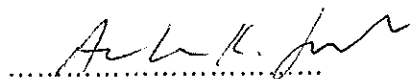

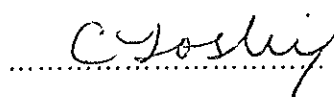
