Council Tax Support.

If you are on a low income and have less than £16,000 savings, you may qualify for Council Tax Support. Visit <https://rbwmclaims.teamnetsol.com> to make a claim. If you have already applied, any amount awarded will be credited directly to your Council Tax account in order to reduce what you have to pay. This will be shown separately on your Council Tax Bill. You must advise us within 21 days of any change which could affect your entitlement. This could include, but is not limited to, changes in your household or the income/capital of anyone in your household. If you fail to report these changes you may be liable for a financial penalty or prosecution. You have the right to ask for a written statement of your entitlement within the next month or to ask us to look at it again. If you disagree with the decision you may be able to appeal to the independent Valuation Tribunal Service. Further information may be found here: www.valuationtribunal.gov.uk
