2. Enter your email address, confirm that it is correct and select 'continue'.

3. You'll receive a code to the email address you provided. Enter this code and select 'confirm'.

4. Select 'continue' when your email address has been confirmed.

5. Enter your full name and select 'continue'.

6. You'll need to create a password and confirm the password. Your password should be no longer than 12 characters. Please make sure you keep a note of the password you create.

7. You'll be asked to set up a recovery word in case you forget your password in the future. Enter this and select 'continue'.

8. You'll be provided with a government gateway user ID, which will also be sent to your email address. You'll need to use your user ID and password every time you sign in. Select 'continue'.

9. Enter your scheme administrator ID and activation token that we have sent to you. Select 'request access'. You'll be able to access the Pension Schemes Online service.
