Continuing Trustees and the Retiring Trustee consent to such appointment

(1)The Principal Employer hereby appoints the New Trustee to be a Trustee of

the Scheme to act jointly with the Continuing Trustees

(2) The Principal Employer hereby removes the Retiring Trustee from the trusts

of the Scheme

(3) The Continuing Trustees and the New Trustee hereby declare that they will

hold all monies deposits securities investments policies property and income

for the time being representing the assets of the Scheme upon the Trusts

thereof and subject to the powers conditions and provisions applicable

thereto
