**Tax credits** (</tax-credits-service/renewals/service-router>)

View your next payments and the people on your claim, and make changes to your claim.

### **Child Benefit** (/personal-account/child-benefit/home)

A payment to help with the cost of bringing up children.

### **Marriage Allowance** (/marriage-allowance-application/history)

Transfer part of your Personal Allowance to your partner so they pay less tax.
