Halfpenny and Spendloff Ltd Executive Pension Scheme

On behalf of Halfpenny and Spendloff Ltd we are pleased to confirm your membership of the Halfpenny and Spendloff Ltd Executive Pension Scheme.

Scheme Structure

- The Scheme is a registered pension scheme, established under trust as an occupational money purchase arrangement, which means that the benefits payable will be based on the contributions paid and/or transfers received on your behalf, together with the growth on the investments held, subject to the Scheme Rules.
- It is open to any employee to whom the principal or a participating employer chooses to offer membership.

Contributions

- A sponsoring employer may, but is not obliged to, pay contributions to the Scheme on your behalf.
- You are not required to make personal contributions to the Scheme yourself, but you may do so if
 you wish, in accordance with the Scheme Rules.
- Please note that your first contribution year (pension input period) will run from the date of your first contribution until the end of the tax year (5 April) in which it was paid. Thereafter, your contribution year will run from 6 April to the following 5 April each year.

Pension Benefits

- You may take your benefits in whole or in part at any time from age 55.
- You will be allowed to take up to 25% of your benefits up to the Standard Lifetime Allowance as a tax free lump sum and the balance can be used to provide an income in accordance with the Scheme Rules.
- The actual amount of benefit will depend on the value of the fund.

Death Benefits

- In the event of your death before crystallising benefits and prior to age 75 your whole fund up to the Standard Lifetime Allowance may be paid tax free to your beneficiaries. Alternatively, the fund could be used to provide dependants' pensions.
- In the event of your death after crystallising benefits or after age 75 your whole fund may be paid to your beneficiaries subject to a 55% tax charge. Alternatively, the fund could be used to provide dependants' pensions.

Administration

- Rowanmoor Group plc fulfils the statutory role of Scheme Administrator.
- Rowanmoor Trustees Limited fulfils the role of independent trustee.
- As a scheme member you will automatically be appointed as a trustee. Details of the responsibilities
 and duties of a trustee are detailed in the enclosed Solo SSAS Trustee Guide.
- The definitive trust deed and rules of the scheme detail how it will be governed and administered.
