The information/documentation we now require has been summarised below. Where we have requested copy documents you can either provide photocopies or scanned and emailed copies.

General Information

- We have a copy of the Trust Deed dated 21 March 2009, and a Deed of Appointment of Trustee dated 24 June 2015. The Deed dated 24 June 2015 refers to a Definitive Trust Deed and Rules dated 25 February 2013. Can we have a copy of this Deed and any other amending deeds.
- A copy of the PSTR registration certificate.
- If the scheme has been registered with the Information Commissioner please confirm the reference.
- A copy of the 2018/2019 registered pension scheme return.

- II. Please provide details of any reportable transactions or payments that have been made, but have not yet been reported.
- III. Please confirm that the Scheme has not made any Unauthorised Payments, as defined in Finance Act 2004. If any such payments have been made, please provide full details, including any correspondence sent to the members, employer, trustees or HMRC about these payments.
- IV. Please advise if the Scheme is, or has been, in breach of any of the regulations of the Pensions Act 1995. Please highlight any areas of non-compliance with the regulations (whether minor or major) and inform us of any reports that have been made to The Pensions Regulator.

- V. Please confirm that no pension sharing orders or earmarking orders have been received by the Scheme.
- VI. If the Scheme holds a Legal Entity Identifier (LEI), please confirm the reference number.
- VII. If the Scheme has registered with HMRC's Trust Registration Service, please confirm the Scheme's Unique Tax Reference (UTR) number.
