INTRODUCTION:



- (A) **Padzzz Limited** wishes to establish the **JENKINS INVESTMENTS SSAS** (the "**SSAS**").
- (B) **Padzzz Limited** intends to apply to HM Revenue & Customs for the SSAS to be registered as a registered pension scheme for the purposes of Part 4 of the Finance Act 2004.

OPERATIVE PROVISIONS:


- (1) **Padzzz Limited** hereby establishes the **JENKINS INVESTMENTS SSAS** with effect on and from the date of this deed.
- (2) The **JENKINS INVESTMENTS SSAS** is governed by the rules attached to this deed.
- (3) The Principal Employer hereby appoints the Member Trustees and the Corporate Trustee to be the first Trustees of the scheme
- (4) **Padzzz Limited** is the first principal employer of the SSAS.
- (5) The first trustees of the **JENKINS INVESTMENTS SSAS** must appoint a person as the first scheme administrator of the **JENKINS INVESTMENTS SSAS** for the purposes of section 270(2) of the Finance Act 2004 who satisfies the criteria in that section.
- (6) No person has any right to enforce any provision of this deed and the rules attached to this deed by virtue only of the Contracts (Rights of Third Parties) Act 1999.
- (7) This deed and the rules attached to this deed are governed by and interpreted according to the laws of England and Wales. The parties to this deed submit to the exclusive jurisdiction of the courts of England and Wales.


