Background

Jenspot SSAS (in this deed called the 'Scheme') is a pension scheme which is now governed by a definitive trust deed and rules dated 18 October 2021 (in this deed called the 'Existing Provisions').

The Trustees are desirous to admit the Participating Employer to the Scheme by Rule 12.2 under the Existing Provisions.

1. Operative provisions

- 1.1 Pursuant to Rule 12.2 of the Existing Provisions the Trustees agree with the Participating Employer that it shall become a Participating Employer. The Participating Employer agrees that it shall at all times until the determination of the trusts of the Scheme duly perform and observe each and every provision of the Scheme which ought to be performed and observed by it as a Participating Employer for the time being.
- 1.2 Unless the context requires otherwise, meanings assigned to words and expressions in the Existing Provisions shall apply to words and expressions not otherwise defined in this deed.
- 1.3 The provisions of this deed shall have effect on and from its date.
