- 7. The scheme is being set up for the 2 members listed in answer number 6. Trisha Theodore-Heath is the director of the sponsoring employer. The Trustees do not anticipate any more members joining the scheme. The scheme will not be marketed. There are no introducers involved.
- 8. The Scheme proposes to invest in commercial property, of which the Trustees both have existing knowledge. The Trustees are currently searching for a suitable commercial property. A business plan will be put in place once a specific deal has been agreed, which will be done once the scheme has been tax registered. A cash balance will be held in short term cash deposits.
- 9. The projected fund value at the end of the first year of the pension scheme's existence will depend upon whether a suitable commercial property has been sourced. Until then, an approximate fund value would be the cash in short term deposits of £200,000.00. The Trustees would be working towards an average of an 8 10% return on a yearly basis.
