## **Parties**

## Recitals

- 3. The General Trustee will undertake all amendments to ensure proper implementation of the changes to the Trusts of the Scheme as may be required by the Existing Provisions.
- 4. The Incoming Employer in question covenants to duly perform and observe each and every provision of the Scheme which ought to be performed and observed by it as the Principal Employer of the Scheme.
- 5. The provisions of this Deed shall have effect on and from its date.
