- 2) MARK PETER NEASHAM of 27 Kirkwood Drive, Redcar, England, TS10 2SX and INDIGO TRUSTEES LIMITED (company number 10863962) whose registered office is at 27-29 High Street, Ewell, Epsom, Surrey, England, KT17 1SB (together the "Trustees")

#### INTRODUCTION:

- C) The Principal Employer wishes to appoint the Trustees to be the first trustees of the Scheme.
- D) The Trustees and Principal Employer wish to appoint INDIGO TRUSTEES LIMITED (company number 10863962) whose registered office is at 27-29 High Street, Ewell, Epsom, Surrey, England, KT17 1SB as the Administrator (the "Scheme Administrator") in accordance with section 270 of the Finance Act 2004.

### **OPERATIVE PROVISIONS:**

- 1) The Principal Employer hereby establishes the Scheme with effect on and from the date of this Trust Deed.
- II) The Scheme is governed by the provisions of this Trust Deed and the attached Scheme Rules with ref: Scheme Rules - Nov18.
- III) The Trustees have agreed to be the first Trustees of the Scheme and the Principal Employer hereby appoints the Trustees as the first Trustees of the Scheme with effect on and from the date of this Trust Deed.

IV) The Scheme Administrator has agreed to be the first Scheme Administrator of the Scheme and the Trustees hereby appoint the Scheme Administrator as the Scheme Administrator with effect on and from the date of this Trust Deed.
