## TRUSTEE RESOLUTION NEPHESH SSAS

Minutes of a meeting of the Trustee of the **Nephesh SSAS** (the "**Scheme**") held at Oakland House, Oakland Terrace, Ty-Coch Lane, Cwmbran, Torfaen, NP44 7AJ on 2<sup>nd</sup> December 2024.

## PRESENT:

- 1.1 It was reported that the purpose of the meeting was to consider and, if thought fit, approve a loan of £60,000.00 (the **Loan**) to **Nephesh Limited** (company number 03448839) (the **Borrower**).
- 1.2 The Borrower is a present Sponsoring Employer to the Scheme.
- 1.3 The Trustee considered the terms of the following draft documents produced to the meeting:
  - 1.3.1 a loan agreement between the Scheme and the Borrower;
  - 1.3.2 an existing charging deed that would secure the proposed Loan under a floating charge over the assets of the Borrower; and
  - 1.3.3 evidence that the value of the security is adequate to properly secure both the proposed Loan and any and all existing liabilities due to the Scheme secured under the above floating charge.

(together, the **Documents**).

- 1.4 It was noted that under section 179 of the Finance Act 2004, the Scheme could only provide the Loan under certain circumstances.
- 1.5 The Trustee has noted that there is an existing loan provided to the Borrower, issued in November 2023. The Trustee has further noted that this existing loan has been serviced in line with the associated loan agreement.
- 1.6 Having taken regard of the existing loan to the Borrower, the Trustee has assured themselves that the additional advancement of the proposed Loan to the Borrower will not compromise HMRC lending rules.
- 1.7 The Trustee has satisfied themselves that the value of the assets covered by the proposed floating charge is sufficient to provide security for both the proposed Loan and the outstanding amount due on the existing loan.

- 1.8 The Trustee considered that the Documents met the requirements of section 179 of the Finance Act 2004 and IT WAS RESOLVED, in exercise of the powers conferred by 5.5 of the Trust Deed and Rules for the Scheme to approve the Documents and that the Trustee be authorised to signed the Documents on behalf of Benefits Scheme.
