Please find attached the next year's schedule of payments. For the last 2 years interest rates were lower and the monthly payment was kept at £1,359.90. This has paid off a little extra loan capital each year. For the next 12 months central bank base rate at 28 May had increased from 0.1% to 1% (it has subsequently increased again to 1.25%). The loan agreement has interest set at a minimum of 5% pa and otherwise central bank plus 4.5% - thus the new rate going forward will be 5.5% until 28 May 2023.

Please can you amend the payments up slightly to £1,363.25 **with immediate effect** and also note a change of bank account from AIB Bank to Metro Bank, same account name Oakleaf SIBA, sort code is now 23-05-80 and account number 45161447.
