Recitals

Operative provisions

- 1. The Principal Employer in exercise of the power conferred on them by 5.3 of the Existing Provisions and all other powers them enabling hereby removes the Outgoing Trustee as a Trustee and Independent Trustee of the Scheme with effect from the Effective Date.
- 2. The Continuing Trustees agree to take all reasonable steps to remove from the Trusts of the Scheme and any of the assets of the Scheme held in the name of the Outgoing Trustee (jointly or alone), including the removal of the name of the Outgoing Trustee from any relevant registration at HM Land Registry.
- 3. In removing the Outgoing Trustee as a Trustee and Independent Trustee of the Scheme, the Outgoing Trustee is hereby discharged from all duties and liabilities as Trustee with effect from the Effective Date.
