## 4. EXPLANATORY NOTES

- 2. This form cannot be used to verify the identity of any customer that falls into one of the following categories:
  - those who are exempt from verification as being an existing client of the introducing firm prior to the introduction of the requirement for such verification;
  - · those who have been subject to simplified due diligence under the Money Laundering Regulations; or
  - · those whose identity has been verified using the source of funds as evidence.
