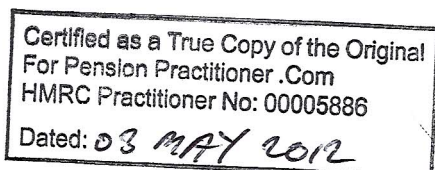
Once the 30 day notice period has been served we will remove ourselves as the Administrator registered to the Scheme and our files will be archived accordingly.
