**Deed of Removal of Trustee**

## Recitals

- (C) The Principal Employer is the present principal sponsoring employer to the Scheme.
- (D) It is desirous to remove the Outgoing Trustee as a trustee to the Scheme.
- (E) The Existing Provisions vests the power of removal of trustees in the Principal Employer.
- (F) In this Deed (including the recitals) 'Effective Date' means the date of this Deed.

## **Operative provisions**

- 1. The Principal Employer, in accordance with clause 4.1 of the Existing Provisions, hereby removes the Outgoing Trustee as a trustee of the Scheme with effect from the Effective Date.
- 2. The parties agree to take all reasonable steps to vest in the Continuing Trustee only the trusts of the Scheme and all of the assets of the Scheme.
- 3. As a consequence of the removal of the Outgoing Trustee of the Scheme, the Outgoing Trustee is discharged from the office of Trustee with effect from the Effective Date and the Trust shall be vested in the Continuing Trustees only.
