Dear Mrigank,

I hope you are well. Apologies I just tried to call you to have a chat about auto enrolment. My colleague Emily has mentioned that you have enquired about auto enrolment.

Auto enrolment is a requirement for your company, not the pension scheme.

I can see that you have received a letter from The Pensions Regulator to your company Red Bridge Capital (UK) Limited, notifying you of your auto enrolment duties and that your stage date was 1st January 2018.

You must set up Red Bridge Capital (UK) Limited into an auto enrolment scheme. I can help you with this.

It is possible that you may postpone the auto enrolment for up to three months from the 1st January 2018, but we do need to set up the auto enrolment now to action the postponement.
