Thank you for the confirmation.

I am sorry to trouble you with this but we need to supply more information to HMRC so that their records are fully up to date and I would like to ensure that this information is correct.

Would you also be able to confirm if the pension payment made on 17 November 2016 for the amount of £24,054 with payment ref. 500032 was made to John's personal account as well?

I would also require a confirmation of the pension payment made in 2015 as I do not seem to have a statement covering this period.

If you could supply the date the payment was made, the amount and confirm if this was paid to John's personal account, that would be much appreciated.

Gavin was under the impression that the employer is also dealing with PAYE on John's pension. However, as all of the payments seem to have been made to John's personal account (to be verified as requested above) rather than going via the employer, this does not seem to be correct. Would you be able to verify if there has been any involvement regarding this on the employer's side?
