The Directors by this Resolution **resolve that:**

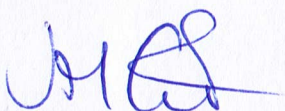
1. An employer's contribution of £50,000 shall be allocated as follows:

Craig Stainforth	£5,000

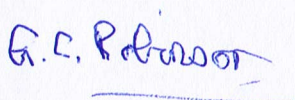
2. The balance of contribution of £450,000 will be held in the Trustee General Account for provision of future pension benefits until such time as the Company shall otherwise resolve.
