Resolution of the Trustees of the Robinson Family SSAS

Date: 3rd July 2019

Interpretation

The Trustees confirm that the terms used in this resolution should be interpreted as they are defined in the Definitive Trust Deed and Rules dated 2nd March 2015 and all subsequent amendments for the Robinson Family SSAS (the "**Scheme**").

Background

- 1) The Trustees have received a request from the member Neil Fewlass to transfer the entirety of his benefits out to an alternative arrangement. The current valuation of the Scheme values his benefits at £7,450.16 (£6,501.84 in Dolphin, £951.00 in Greyfriars, and a negative cash balance of £2.68).
- 2) The Trustees have also received a request from George and Josephine Robinson to each take their full available pension commencement lump sums (PCLS) and to withdraw the remainder of their funds as drawdown. The current valuation of the Scheme values their benefits at £19,878.00 each (each fund comprised of £19,603.00 in Greyfriars and a cash balance of £275.00).
- 3) Due to the earmarked nature of the assets of the Scheme, each member currently has non-cash assets specifically earmarked for them. It is desirous to swap these assets with cash available in the General (unallocated) Fund to provide sufficient liquidity to the members to achieve their respective goals.

Resolution

- 1) Having considered the request from Mr Fewlass, the Trustees have raised no objections and resolve to facilitate his request. The Trustees further resolve to authorise the notional purchase by the General Fund of Mr Fewlass' allocated non-assets at par valuation. As a result of this, Mr Fewlass' benefits will comprise of £7,450.16 in cash only. The Trustees will instruct the relevant parties to assist in the final transfer of Mr Fewlass' benefits.
- 2) Having considered the request from Mr and Mrs Robinson, the Trustees have raised no objections and resolve to facilitate their request. The Trustees further resolve to authorise the notional purchase by the General Fund of Mr and Mrs Robinson's allocated non-cash assets at par valuation. As a result of this, Mr and Mrs Robinson's benefits will each comprise of £19,878 in cash only. The

Trustees will instruct the relevant parties to assist in the payment of Mr and Mrs Robinson's PCLS and subsequent drawdown amount.

3) To confirm, subsequent to the above, the General Fund will have an additional £40,157 from the Greyfriars investment and £6,501.84 from the Dolphin investment allocated to it, and £46,658.84 deducted from its allocated cash balance.
