Deed of Removal of Trustee

SAVENT LIMITED EXECUTIVE PENSION SCHEME

THIS DEED is dated: 19/8/2022

- 1. **Cranfords Trustees Limited** (Company No 09771053) whose registered office is situate at International House, Constance Street, London, England, E16 2DQ (in this deed called the '**Outgoing Independent Trustee**'); and
- 2. Susan Jane Savage of 5 Heartwood Close, Wollaton, Nottingham, NG8 1BF and acting as Trustee of the SavEnt Limited Executive Pension Scheme (in this Deed called the 'Continuing Trustee').

Recitals

- (A) **SavEnt Limited Executive Pension Scheme** (in this deed called the '**Scheme**') is a pension scheme which is currently governed by a Trust Deed dated 8th July 2014 and all subsequent amending deeds and documentation (in this deed called the '**Existing Provisions**').
- (B) The Outgoing Independent Trustee is the present Independent Trustee of the Scheme.
- (C) The Continuing Trustee is the present Member Trustee of the Scheme.
- (D) It is desirous to remove the Outgoing Independent Trustee as the Independent Trustee and Trustee of the Scheme.
- (E) In this Deed (including the recitals) "Effective Date" means the date of this Deed.
- (F) As a consequence of the removal of the Outgoing Independent Trustee of the Scheme, the Trusts shall remain vested in the Continuing Trustees.

Operative provisions

- 1. The Outgoing Independent Trustee and Continuing Trustee, in exercise of the power conferred on them by 5.3 of the Existing Provisions and all other powers them enabling, hereby remove the Outgoing Independent Trustee of the Scheme with effect from the Effective Date.
- 2. As a consequence of the removal of the Outgoing Independent Trustee of the Scheme, the Outgoing Independent Trustee is discharged from the office of Trustee with effect from the Effective Date and the trusts of the Scheme shall be vested in the Continuing Trustee alone.
