- (G) The Principal Employer wishes to remove the Outgoing Independent Trustee as trustee and Administrator.
- (H) The Outgoing Independent Trustee, in its capacity as Administrator, consents to its removal as trustee and Administrator, and to the appointment of the New Independent Trustee.
