#### **Parties**

### **Recitals**

- 2. The power in Rule 4.1 (Power of Appointment and Removal of Trustees) may be exercised by the Trustees.

The Scheme will continue to be run as a Closed Scheme until and unless such time that a new Principal Employer is appointed.

The provisions of this deed shall have effect on and from its date.
