If you request Manchester City Council to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit by Manchester City Council or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society.
If you receive a refund you are not entitled to, you must pay it back when Manchester City Council asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify Manchester City Council.

Empty property relief

Properties that have been empty for more than three months, or for more than six months if they are industrial properties, do not receive a reduction in their Business Rates. We charge 100 per cent of the Business Rates as if the property was occupied. For more details go to www.manchester.gov.uk/businessrates and pick 'Empty properties and business rates'.

For the 2012/2013 financial year, we do not charge rates on unoccupied properties with a rateable value of less than £2,600.
