

Deed of Removal of Practitioner

Dated: 28/4/2022

Parties

1. **David William Hargreaves** of No.1 West Bank, Dorking, Surrey, RH4 3BZ (in this Deed called the “**General Trustee**”); and
2. **Cranfords Trustees Limited** (company number 09771053) whose registered office is situated at International House, Constance Street, London, England, E16 2DQ (in this Deed called the “**Independent Trustee**”); and
3. **The Practitioner Partnership LP trading as Pension Practitioner** (company number 06028668) whose registered office is situated at 1st Floor, World Trade Centre, Baytree Road, Gibraltar, GX11 1AA (in this Deed called the “**Pension Practitioner**”).

Introduction

1. The General Trustee and the Independent Trustee are the present trustees of the **TSP Pension Scheme** (“the **Scheme**”), which is a retirement benefits scheme established and governed by a Trust Deed dated 11th September 2015 and all subsequent amending documents (the “**Existing Provisions**”).
2. Clause 5.4.2 of the Existing Provisions vests in the trustees the power to appoint and remove advisors and officers as they consider desirable.
3. The General Trustee and the Independent Trustee are desirous to remove the Pension Practitioner from the Office of Practitioner pursuant to a Trustee resolution dated 28/4/2022

Operative Provisions


The General Trustees (in acting in their capacities), removes the Pension Practitioner as their agent and Practitioner in connection with, but not limited to any matters within the responsibility of HMRC and any other thing whatsoever in connection with or incidental to the discharge of all duties relating to the Scheme which are imposed on the scheme administrator and/or the maintenance of the registered status of the Scheme under Part 4 of the Finance Act 2004.


The provisions of this Deed have effect on and from its date.
