C The Continuing Trustees hereby declare pursuant to Section 40(2)(a) of the Trustee Act that they will hold the funds investments policies contracts and other property of the Plan (whether real personal or otherwise) upon the trusts thereof and with and subject to the powers and provisions applicable thereto and for the time being in force


