

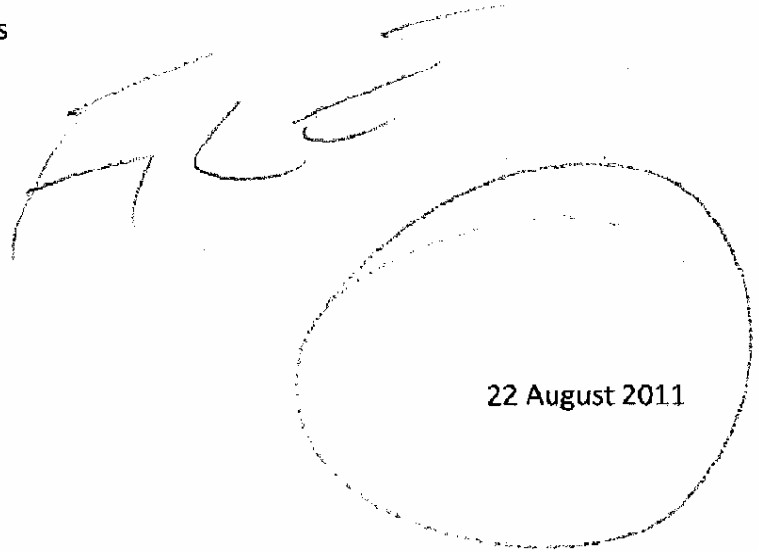

PAYE FOR PENSIONS

We have received new PAYE codes from HMRC for the pension scheme.

Going forward, the P11 and P35 returns will be undertaken electronically. The tax due in respect of the pension to you and Mrs Hancock will be assessed and remitted via the new PAYE codes in respect of your pensions.
