## **Recitals**


- (A)   **Vortex Design SSAS** (in this Deed called the 'Scheme') is a pension scheme which is now governed by a Definitive Trust Deed and rules dated 27 July 2001 (in this Deed called the 'Existing Provisions') and all subsequent amending documentation.
- (B)   The Continuing Trustee is the present trustees of the Scheme.
- (C)   It is intended that the New Trustee be appointed as trustee of the Scheme


## **Operative provisions**




