Have a chat with Farid. Sorry it is not a service that we provide as an accountant will need to set up the vat registration and file the vat returns. The vat registration can be set up online on the HMRC website.

Once your scheme is registered, I would be very grateful for a copy of the vat certificate and then the vat returns can be paid from your pension scheme AIB bank account. Either let me know when each payment needs to be made or I can set up a direct debit with HMRC. Once you are registered, I will also send you a HMRC form for any refunds to be paid direct into your AIB bank.
