The FSCS have requested the following information;

- The name, address and financial services regulator number of the firm that originally sold the policy
- A copy of the original application form
- A full transaction history showing all fund switches, or a copy of any written fund switch instructions received
- If the policy has been transferred to another provider, the value of the transfer
- A history of policy servicing agents
- A current schedule of investments with valuation
- A history charges, withdrawals and contributions to the policy
- The investment fund(s) in which the policy was invested
- The SIPP's current schedule of investments and a valuation of them
- Balance of the SIPP bank account and amount of any charges owed to Cranfords but unpaid due to illiquidity.


