We are the government body responsible for child maintenance. We oversee the services that work out, collect, enforce and distribute child maintenance payments on behalf of separated parents.

In England, Wales and Scotland these services are provided by Child Maintenance Service and Child Support Agency.

In Northern Ireland, the service is provided by Child Maintenance and Enforcement Division, which is part of the Department for Social Development.

#### Employers – our valued partners

Thank you in advance for your help in collecting child maintenance payments. We know that employers are some of our most valuable partners in helping us collect payments through employee deduction from earnings orders (DEOs).

You'll learn more about this in the enclosed booklet, A partnership for children: an employers' guide to child maintenance. It includes more information about:

- what a deduction from earnings order is
- how to register for our online service for employers the easiest way to manage your DEOs
- how to make payments to us

If your payroll services are managed by a third party agent like an accountant or a payroll bureau you can



register them to administer your DEOs on your behalf if you haven't already done so. We'll then deal with them directly – although we'll always send you duplicate copies of any correspondence.

Please note two things:

- Agents such as accountants, payroll bureaus and other third-parties are not given usernames and passwords for their clients' online self-service accounts.
- Until we finish moving cases to the new statutory child maintenance scheme you may have employees who still pay DEOs under the 1993 or 2003 child maintenance schemes. You may be contacted separately about this.

## What happens next

You may have already seen your first DEO schedule. You can find it online – it's quick and easy to set up your Self Service account at **childmaintenanceservice.direct.gov.uk/employer**. This will confirm the information you'll need to set up regular deductions from one of your employee's earnings. We'll issue a new DEO schedule every month. If you ask us to we'll also send you your DEO schedule by post.

Your payments will always be due by the 19th of the month after the date the schedule is issued. Please note that you are required by law to pay us child maintenance payments, when we ask you to, from one or more of your employees. If you don't send us the payments listed in your payment schedule and don't explain why you haven't sent them, we can take you to court.

#### Help and information for employers

The Child Maintenance Service is the government body responsible for child maintenance services in Great Britain.

It is a business unit of the Department for Work and Pensions and is made up of the Child Maintenance Service and the Child Support Agency. These are the services that work out, collect and pay out child maintenance payments on behalf of separated parents in England, Wales and Scotland.

In Northern Ireland this work is carried out by the Child Maintenance and Enforcement Division, part of the Department for Social Development.

The Child Maintenance Service works together with around 30,000 employers in Great Britain and Northern Ireland to administer the payment of child maintenance by deduction from earnings order (DEO). Together they help get up to £300 million a year in child maintenance to parents with the day-to-day care of children.
