Deed of Appointment of Trustees

Parties

- Tradeship Publications Limited (Company No 02218297) whose registered office is situate at Old Kings Head Court, High Street, Dorking, Surrey, RH4 1AR (in this deed called the 'Principal Employer');
- Susan Hargreaves of Woodpeckers, New Park Road, Cranleigh, GU6 7HJ (in this deed called the 'Continuing Trustee'); and
- Melanie Palin of 9 Beckley Court, Beckley, Oxfordshire, OX39UB (in this deed called the 'New Trustee').

Recitals

- (A) Hargreaves SDF Pension Scheme (in this Deed called the 'Scheme') is a pension scheme which is now governed by a Definitive Trust Deed and Rules dated 17th March 2008 and all subsequent amending deeds (in this Deed called the 'Existing Provisions').
- (B) The Continuing Trustee is the present sole trustee of the Scheme.
- (C) The Principal Employer is the present sponsoring employer to the Scheme.
- (C) It is intended that the New Trustee be appointed as a trustee to the Scheme.
- (D) In this Deed (including the Recitals) 'Effective Date' means the date of this Deed.

Operative provisions

- Pursuant to Rule 4.1.2 of the Existing Provisions, the Principal Employer appoints the New Trustee as a trustee to the Scheme.
- The New Trustee consents to their appointment as a trustee to the Scheme.
- The Continuing Trustee and New Trustee hereby covenant to act together for the purposes of the Scheme.
- The parties agree to take all reasonable steps to vest in the Continuing Trustee and the New Trustee the trusts of the Scheme and all of the assets of the Scheme.
