We would also, to start with, need confirmation of your taxable income for the tax years in question, or, at least, confirmation that your taxable earnings have not exceeded £110,000 in any given year. If taxable earnings have exceeded £110,000, then we would need to look a lot closer at his precise earnings, as this may well have a knock-on effect on your annual allowance (tapering could become a factor, thereby reducing his annual allowance).
