In accordance with the terms of your agreement, we have undertaken a review of your monthly variable rate loan repayments (with a margin of 2.75% over base rate) to ensure that these are sufficient to repay the loan on its Final Repayment Date of 30 March 2022. We would like to remind you that there will be a lump sum repayment instalment on the Final Repayment Date which will repay all sums due under the loan agreement.

As a result, we have determined that the amount of your monthly repayment could be decreased from £1,447.15 to £1,388.64.
