- B. The Outgoing Trustee having no further benefit in the Scheme wishes to retire as a Trustee of the Scheme.

- D. As a consequence of the retirement of the Outgoing Trustee of the Scheme, the Trusts shall remain vested in the Continuing Trustees.

Operative provisions

- The Outgoing Trustee retires as a Trustee and the Continuing Trustees under Rule 2.2.2. consents to their removal as evidenced by their execution of this Deed.
- The Outgoing Trustee is discharged from the office of Trustee with effect from the Effective Date and the Trust shall be vested in the Continuing Trustees.
- The Outgoing Trustee shall be removed from the Land Registry and any titles documents and including leases by the Continuing Trustees.
