Fixed penalty notice Issued under section 40 of the Pensions Act 2008

Amount of penalty: £400

The Pensions Regulator is of the opinion that you, an employer, have failed to comply by 5 December 2022 with one or more of the requirements of the Compliance notice issued to you on 24 October 2022. This is the period to which this penalty relates.

This fixed sum penalty of £400 has been issued against you for this failure and must be paid to The Pensions Regulator by 17 January 2023.

How to comply

In addition to paying this penalty you must comply with the Compliance notice dated 24 October 2022 by 17 January 2023.

What happens if the failure to comply continues

If you fail to comply with the requirements of the Compliance notice by 17 January 2023, The Pensions Regulator may issue you with an Escalating penalty notice under section 41 Pensions Act 2008. This is regardless of whether you pay the fixed penalty. The escalating penalty would accrue at a daily rate which varies from £50 to £10,000.

How to pay your penalty
