## Introduction

- 1. - 1. The Principal Employer under the power vested in them by Clause 5.3 of the Existing Provisions hereby appoints the Incoming Independent Trustee as a professional trustee to the Scheme.
- 2. The Principal Employer under the power vested in them by Clause 5.3 of the Existing Provisions hereby removes the Outgoing Independent Trustee from its position as a professional trustee to the Scheme.
